STRATEGY FOR THE MAINSTREAMING AND INSTITUTIONALIZATION OF THE GENDER PERSPECTIVE IN THE MEXICAN SUPREME COURT OF JUSTICE

The General Lines of Work 2019-2022 of the Chief Justice of the Mexican Supreme Court of Justice and the Chair of the Federal Judiciary Council, Arturo Zaldívar, establish gender equality as one of the cross-cutting pillars of institutional work.

For their implementation, multiple lines of action have been developed and organized into 3 main focuses that together seek to: improve working conditions by reconciling the personal and working lives of all public servants, especially women; achieve a real balance in the composition of courts of law and women's access to decision-making positions; and improve the administration of justice so that judges can incorporate a gender perspective when deciding the cases brought before them.
